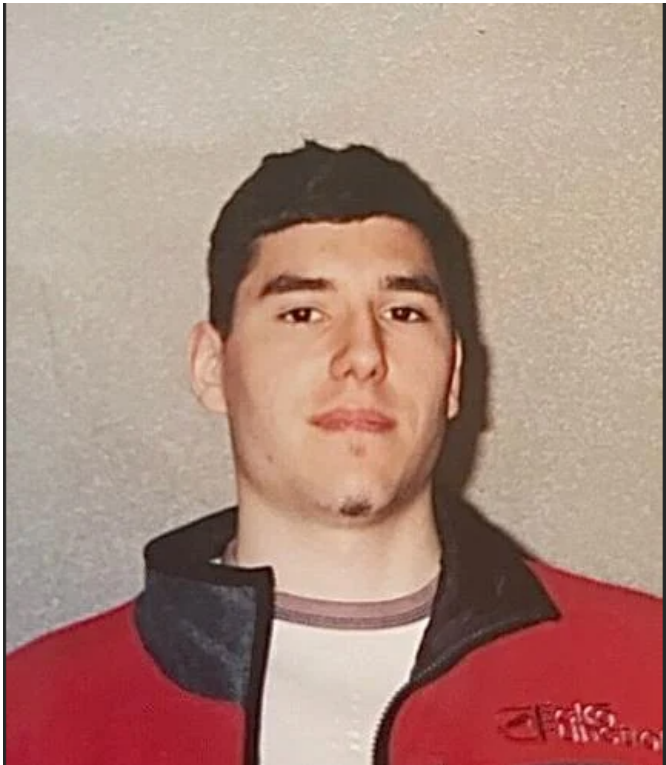

Details of Disappearance

Andrew was last seen at approximately 8:00am on [Federal Forest Rd. 162](#) just 1.9 miles [north of State Hwy 70](#) near Draper (Closer to Loretta now). His silver 2001 Chevrolet Impala was located at the location he was last seen. The vehicle had been left out of gas with the keys in the ignition and the doors open. The following Monday, the sheriff's department learned an endangered missing persons report had been filed in the state of New York for Andrew Bliss. The report stated that Bliss had recently quit his job and that he was depressed over a recent break-up. In the following days multiple search and rescue teams conducted ground and aerial searches in the area, but nothing was revealed.

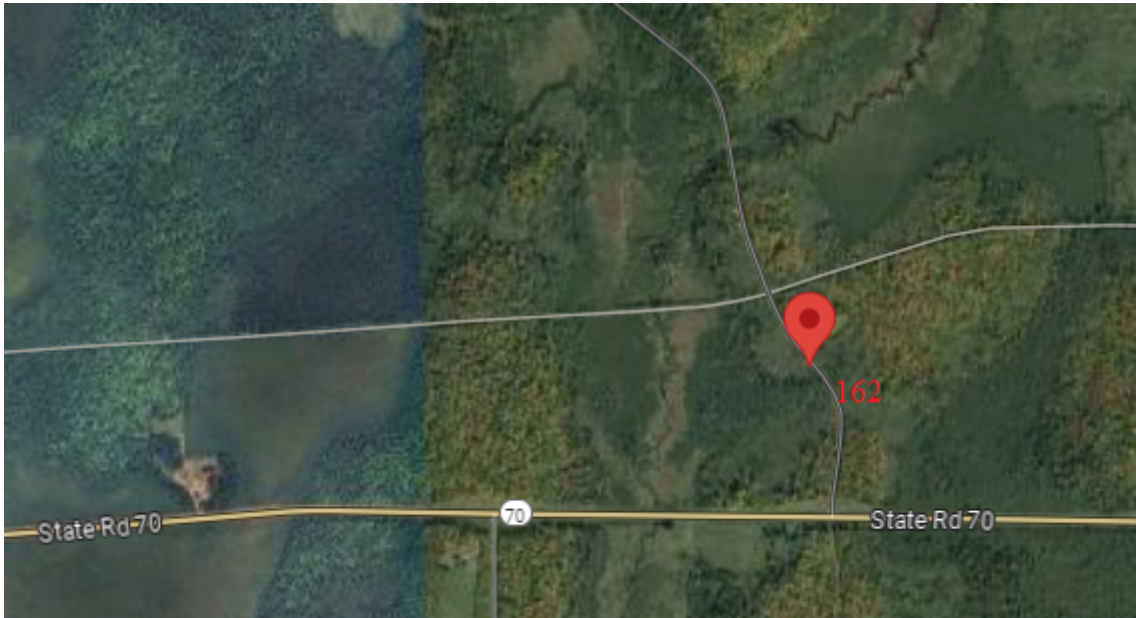

On Thursday, June 26, 2003 I, Sgt. Joanis, observed a news broadcast that Bliss was missing in Sawyer County. I remembered Deputy N. Deegan advising me of a contact he had with a male out of New York sometime last week. I contacted Deegan today at about 0700 hours and asked about the contact. Deegan stated he assist Bliss on the above date and time as Bliss' vehicle was broke down. Deegan stated Bliss was acting odd as he would ask questions, Bliss would answer, but it seemed as if Bliss was not listening.

Bliss' vehicle was covered with mud and Bliss stated he went in the ditch but stated he did not know where. Deegan did a pat search of Bliss and did not locate anything illegal. Bliss was transported by Deegan for what ever he needed for the vehicle and transported back to his vehicle. The vehicle was repaired and Bliss was sent on his way with no charges/citations.

I contacted Sawyer County and the male stated he would have the Sheriff or Undersheriff call me back. At about 0800 hours Deputy Gillie contacted me and asked me to facsimile him the contact as it provides time periods for contacts with Bliss. I sent this via facsimile to Gillie.

I then transported Bliss back to his vehicle and he put the gas in the vehicle. Bliss then started the vehicle and got out and put the gas can in the trunk of the car. I observed as Bliss was in the truck that he had several pairs of clothes located in the trunk. I looked in the front of the vehicle through the windows and did not see anything out of the ordinary.
