

Details of Disappearance

From Justice Be Served: Robert Christian went missing during a trip from Madison to Baraboo on September 16, 1977. On September 16, 1977, he had dinner with his parents, at their Madison home. After eating, he tossed a change of clothes and his bow hunting gear into the back of the Hornet station wagon at about 5:30 p.m. and headed to the bank. After picking up \$25, he planned to drive to Baraboo and meet a friend, local resident Randy Griffith, for Saturday morning deer hunting in the Baraboo Bluffs. If they were not successful taking a deer, Robert planned to return to Madison that afternoon and attend a Wisconsin Badgers game.

He stopped at a nearby Walgreens and picked up a pack of small cigars. Robert probably drove to the Madison Beltline Highway, headed west to Highway 12 and took it north to the Baraboo area.

At about 9:30 p.m. Randy Griffith's mother, a longtime family friend, called to say Robert had not arrived in Baraboo. Robert's family began calling authorities in Dane, Sauk and Columbia counties to find out if Robert had been involved in a car wreck. They also called the Madison police, who eventually took a report on the disappearance and conducted an investigation.

At about 8 p.m. the Friday of the disappearance, a Mauston woman visiting a nun near the Durward's Glen retreat site encountered a car in her friend's driveway that matched the description of the Hornet and had the same license plate. The young male driver of the car matched Robert's description and told the woman something like "I'm looking for my friend. I'm supposed to meet my friend." The young man said he must be at the wrong place and then drove away to the east, away from the relay tower.

Robert's vehicle was later recovered parked in a driveway near the State Patrol relay antenna on Tower Road southeast of the city, located at E13535 Tower Rd. The wheels, tires and the battery was gone.

The Sheriff's Department followed up on a tip and found four old tires and the hubcaps from the Hornet in a quarry just south of the Badger Army Ammunition Plant and north of Prairie du Sac. Apparently, somebody had switched the tires from the new car for worn-out tires on their vehicle and then dumped the hubcaps. It is unknown if the stripping of the car and Robert's disappearance are connected, or if somebody found the Hornet after he disappeared and took what they could.

The Sheriff's Department brought in a bloodhound that followed Robert's trail a short distance from where he car was found, then lost the scent at Tower Road. They also used a National Guard helicopter to search open fields in the area.



Hunting map version. X is the spot of the relay tower.



Details of Disappearance

Gene J. Cloud Jr. was last seen on January 25, 2012 near the Millston area in southern Jackson County. It has been reported that Gene was observed a short time later walking on Highway O, but his whereabouts since that time is unknown.

At first Gene was assumed to have disappeared willingly, and the missing person search was slow to take hold. When family and friends became concerned that he hadn't made contact with anyone, a search party was formed by tribal party members who were able to trace Gene's footprints through three-foot deep snow. The footprints showed he had walked over 3 miles away from where his car had broken down. He had been walking in the woods parallel to the road and had even crossed back and forth over the road into the woods a few times. Ultimately the Jackson County Sheriff's Department brought out tracking dogs who were able to pick up his scent, but then lost it at the road. It is unknown if Gene got into a vehicle at this location.

The investigation into this missing persons case is still open, but Gray said they have exhausted every lead they have had.

Quote from a local: "Mine and several others thoughts are that he got a ride from the wrong person after he ran from police. He was just given his percapita money. Over 100,000 and he had a baby on the way. His mother said that every penny is still in the account. He never came back for it."





Search Party Fails to Find Woman

A large search party and a helicopter combined for a ground and air search Sunday in the area west of Rhineland, seeking some trace of a 56-year-old woman who has been missing from the Country Farm nursing home since Thursday.

Sheriff Jack D. Phillips said the ground search involved members of Search and Rescue Explorer post, the Oneida County Emergency Corps and a number of volunteers. About 50 persons were involved.

Meanwhile, county officers checked out several reports that a woman answering the description of Jean Colborne, the missing person, had been seen in the Woodruff area and in the McNaughton region.

Mrs. Colborne has short brown hair, slurred speech and drags one leg when she walks. She was last seen wearing a navy blue top with red trim and red print slacks.

Officers said there is a possibility she was picked up by a passing motorist and given a ride to an unknown destination.


