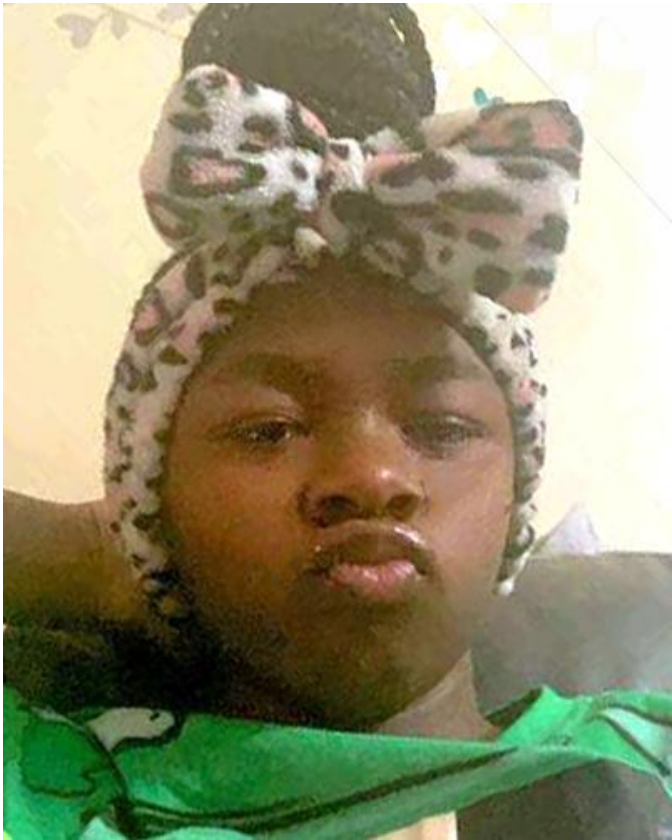

Details of Disappearance

From Doe Network: Laurie Depies, of Appleton, left her job at the Graffiti Store in Fox River Mall. Depies had planned to meet her boyfriend at his apartment at [310 West Wilson Avenue](#), where he was waiting with his sister and a friend of Depies. About 22:15, the boyfriend heard her car's loud muffler and a door slam when she arrived home, but Depies never made it into the apartment. When Depies did not show up at the apartment, they saw her empty vehicle and began looking for her. Eventually, they called the Menasha Police Department. Her gray 1984 Volkswagen Rabbit was located less than 40 feet from the apartment in Menasha. The car was locked. A soft drink cup was found on the hood on Depies' car, but there were no other signs of her at the scene. There was no evidence in the parking lot that Depies was taken forcibly. There was a confession to her murder but the body was not found where the "killer" said it would be.

Details of Disappearance

Ashland County Sheriff's Deputies, along with U.S. Forest Service, begin a search, which yields no results. July 17, 2019: Search continues with ground and K-9 teams from Sawyer County Search and Rescue and St. Louis County Search and Rescue. No new leads. August 6, 2019: Another search is conducted at the campsite area with K9s. Still no new leads. Team MibSAR conducted an extensive search of the 1.5-million-acre Chequamegon-Nicolet National Forest, but the search yielded no results. Search methods included ground, K-9, water, underwater, and drone searches, but no trace of Richard has been found.

This is not an approved hunting place. It is approved for fishing, hiking, and other things.

Details of Disappearance

Duvall was last known to be in the Manitowoc area in the autumn of 1988. Duvall was reported missing by her ex-husband on October 1, 1988. Cheryl's ex-husband had full custody of their 2 children, and they visited Cheryl on the weekends. He said that they had a friendly relationship over the 4 years they were divorced. At the time of her disappearance she was living with John Michael Neuser, her boyfriend.

The farm on [South Parkview Road](#) and another property in the [Town of Cato](#) were searched. The police found evidence and sent it to the lab but results came back inconclusive. John has been a person of interest but he has not been named a suspect.
