Ring doorbell footage caught Carvell Jennings walking near 66th and Brentwood on Mother's Day afternoon.

## Details of Disappearance

In December 2020, Aaron's vehicle was located near the intersection of [Perch Lake Road and Fire Lane Road](#) in Birchwood, Wisconsin. A witness saw a person who is believed to be Aaron walking near this location on October 12, 2020.

A month before he disappeared he started to change. "Maybe there was some substance abuse," said Johnson's wife, Amanda Thayer. "On December 15th or 16th [2020,] a citizen posted a photo of Aaron walking in his undergarments, and that person was the last to ever see him."

Amanda said Aaron called her at work on the evening of October 10, 2020 and they argued about bills. Aaron told her he was going to stay with some friends. The next day, those friends dropped him off to pick up his truck that was left on the side of the road with a brake line issue. They last saw Aaron at about 6 p.m. Although the truck had a brake line issue, it was still drivable. Amanda explained that Aaron struggled with his sobriety since his release from prison in December of 2019.

A further search of the area turned up clothing items in various locations, including Johnson's gloves, his clean boots, and pants containing his identification, as well as a check and some cash. These items were scattered over a mile-long area west of Fire Lane Road and south of where the truck was found. Searchers also noted a small teepee Johnson had apparently set up on top of a ridge, close to his truck and within sight of the road.

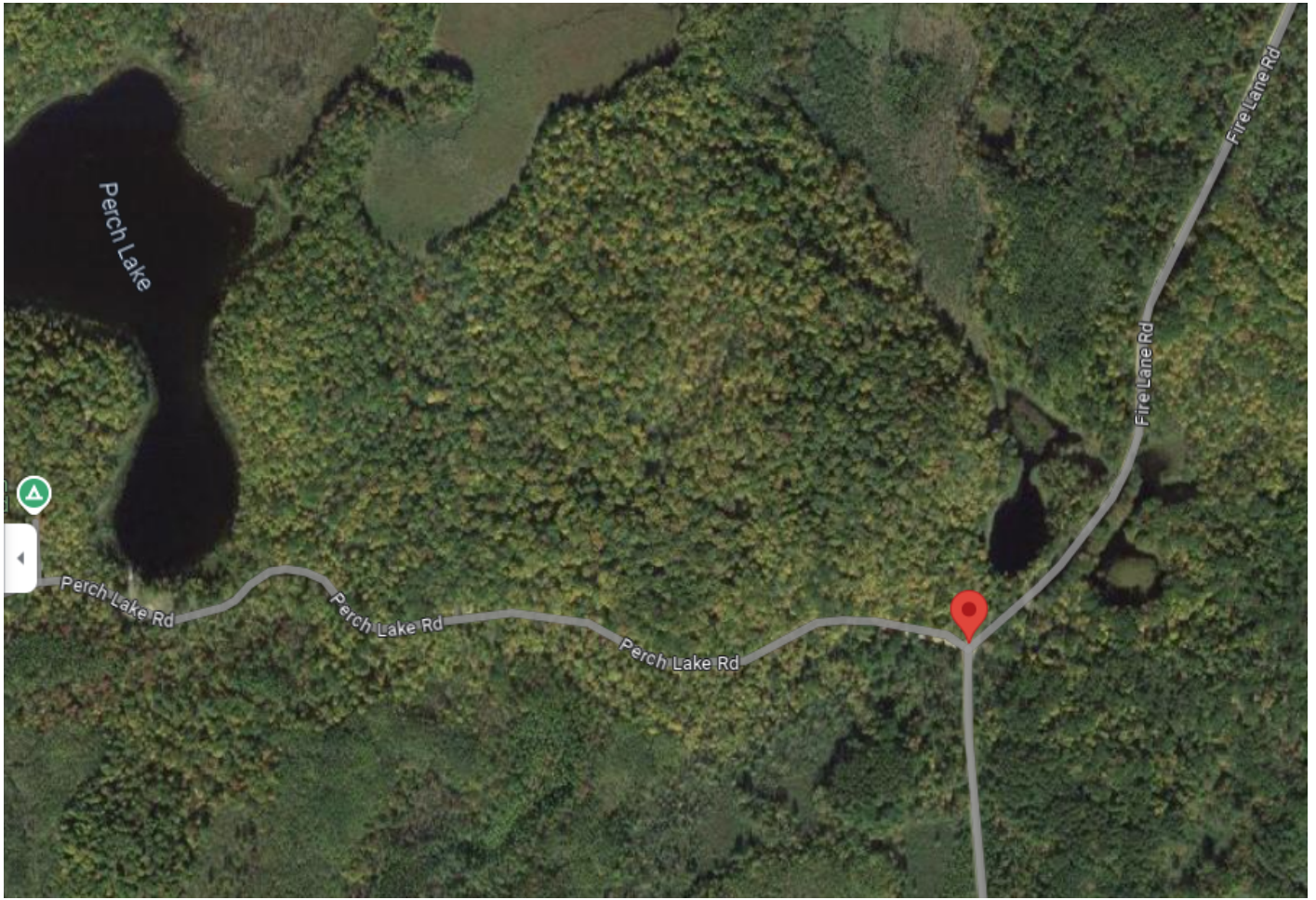

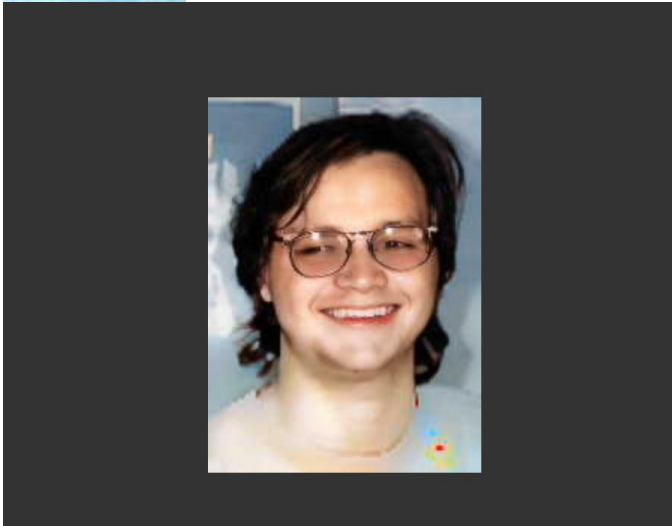

## Details of Disappearance

Cindy Jones was last seen on June 29, 1984 by a neighbor as she was involved in a violent domestic abuse incident with her husband Norman Jones. Cindy was bruised and bloody and screaming for help from inside her home. The neighbor contacted police who went to the residence and were told by her husband Norman Jones that Cindy had left the home out the back door. Police did not check the residence for Cindy. Norman Jones later confessed to a girlfriend that he had beaten and strangled Cindy and buried her body in a gravel pit at a jobsite in Park Falls or Medford. Norman was charged with Cindy's murder in February of 1985. That charge was dismissed in May of 1985 as Investigators were not able to locate Cindy's remains. Norman fled the state after his release, murdered a female acquaintance in Florida in 1990, and then killed himself as Police closed in on him to make the arrest. Cindy's remains have never been located.

## Details of Disappearance

Theodore Jost is a U.S. Army Veteran. The Portage County Sheriff's Department was asked on Aug 30th, 2012 to do a welfare check on Theodores mother, Marie Jost. The Social Security Administration had been unable to contact Marie Jost, even though her Social Security checks were still being cashed. Theodore qualified for Social Security benefits but never applied for them.

Upon arriving the police made contact with Marie's son, Charles T. "Butch" Jost but he claimed his mother was traveling with Theodore. He was unable to provide a description of a vehicle and refused to allow the police to look around the property. According to the Wisconsin Department of Transportation, neither Charles nor Theodore own any vehicles and neither have a valid driver's license.

Two neighbors, who had lived in the area for years, were interviewed and both claimed to have never seen an elderly woman at Charles' residence. Please see Charley Project for all the developments afterwards. However, both of their remains are still unaccounted for.

Per Charley Project: Jovaag was last seen in Holcombe at 11:00 a.m. on June 30, 2015. She didn't have a vehicle and typically walked to get places. The surveillance video at a gas station near her residence showed her walking in the direction of home, and a neighbor saw her near the end of her driveway. She has never been heard from again. An extensive search of the area turned up no indication of Jovaag's whereabouts. Authorities don't believe she is still alive, but foul play is not suspected. Maiden name was Ewer, Michael Jovaag ex husband, she had also been married to Scott Gehrt who died recently. Both divorces were long ago and they all seemed on good terms.
