

## Details of Disappearance

On December 6, 1989 Kerry O'Brien-Krueger was reported missing by her husband. Tracy Krueger reported her missing after receiving a phone call from her coworker at Gander Mountain who was concerned when she failed to show up for work. Krueger told police he believed Kerry was away on business in Wyoming. Police later learned there was no trip scheduled. She has ties to the Madison area.

Husband's Statements: Gave conflicting information about her travel plans and whereabouts Held in January 1990, a polygraph test of her husband had results inconclusive. Husband suffered a stroke that affected his memory, so he has not been questioned further. After extensive questioning of friends and family members, police were still unsure whether Kerry disappeared of her own accord or if foul play was involved. She showed no signs of depression and there was no history of family trouble. She has never been seen again. Her daughter strongly believes her father had nothing to do with it.

## Details of Disappearance

O'Neill was last seen in Lake Geneva on June 18, 1997. She has never been heard from again.

Rumors from Websleuths: "I and a great number of individuals who have investigated this case over the years believe Julia was murdered in retaliation for putting a powerful drug dealer in jail. Her last known contact was with a confidential informant. Julia had just been busted earlier in 1997 with cocaine and was a heavy user. She told her sister she was afraid of going to jail. The man who was sentenced based on Julia's cooperation with authorities after her arrest, as well as several of his associates, are the prime suspects in the case. Through the grapevine, there's been talk that Julia's body was dumped in Lake Michigan." Her parents hired a private investigator, to no avail.


