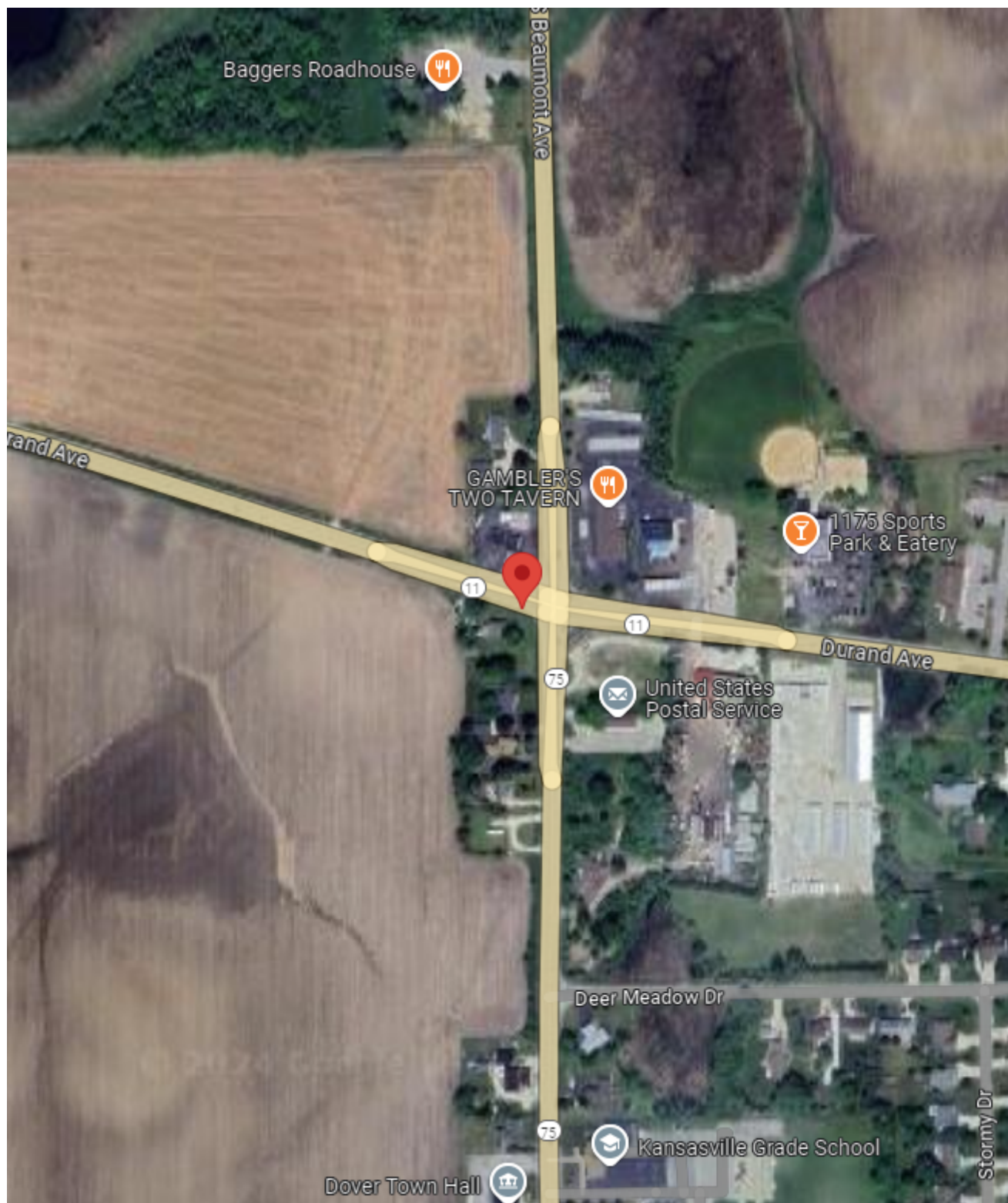
## Details of Disappearance
